INFORMATION SHEET

- Entry to this event is only open to young people and youth workers from affiliated clubs/groups/projects.
- Each club, group or project may bring no more than 10 young people in total.
- All young people must be accompanied by appropriate adults throughout the event. **A minimum ratio applies; no group may attend with fewer than 3 staff members.** You should also undertake your own risk assessment to determine whether you need more than 3 staff members with your group.
- Please ensure all young people complete your organisation's parental permission, medical and photographic consent forms prior to the event. Staff should also complete medical forms. Please bring copies of all these with you on the day. If you do not provide all the forms necessary we cannot allow you to take part in the event.
- Youth workers are responsible for the young people they bring throughout the event and agree to ensure that all instructions given by the event staff are followed.
- You are responsible for making your own arrangements for travelling to and from the event.
- Fairthorne Manor is a non-smoking venue (both inside and outside). This applies to both young people and leaders.
- If anyone wishes to leave the event early they must inform YCHLOW staff.
- **All registration forms must be completed and returned by 26th May along with a cheque for £5 per participant made payable to YCHLOW. This is non-returnable unless YCHLOW cancel the event.**
- Things you need to bring...
 - Lunch and Refreshments
 - Appropriate clothing & footwear (or you will not be able to take part in outdoor activities)
 - A complete change of clothes (in case you get wet or dirty)
